2. All members must contribute three finished ceramic pieces per Club session or 10% of their **output** (whichever is greatest) for sale by the Club.
3. Regular membership is **\$120 per session**. Note the modifiers below:
  - Registrations of continuing members which are received (postmarked) **14 days after December 28 due date (January 11)** should include a \$15 late fee (\$135 total). Members who fail to register and pay fees within the allowed dates will be discontinued from the Club.
  - New members who join after the mid-session date (start date plus 2 months) should pay only for a half-term membership, \$60.

# Waiver and Release of All Claims and Permission to Secure Treatment
